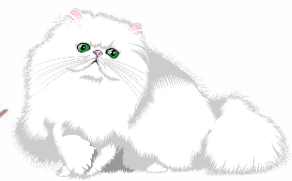

## Deposit Receipt Terms of Agreement

- \* Buyer understands and agrees that the total purchase price of the kitten (s) is subject to change depending on the additional fees added at the time Kitten Contract is signed. These additional fees may include a delivery fee, carrier cost, etc. and will be noted on the contract form.
  - \* The above kitten(s) will not be released to the new owner until the agreed upon purchase price (including additional fees) is paid in full by the time the kitten(s) is/are 10 weeks of age. If the full amount is not paid in full prior to the 10 week time limit, the terms of the agreement are null and void and the deposit will NOT be refunded and will be considered payment for boarding, grooming, feeding and lost opportunity for placement as well as costly advertisement fees required to find the kitten another home.
  - \* The deposit is non-refundable should the buyer, for any reason, change his/her mind about purchasing the kitten(s). However there is one exception which is to deferr the deposit to the next litter with a one time limit. The expiration of the deferred deposit is one year.
  - \* The above kitten(s) is/are being held for the buyer, no other deposit will be accepted on said kitten (s)
  - \* Waitlist customers (only) understand that KCC cannot guarantee availibilty of color, sex, price or facial features of unborn litters. If buyer has put forth a deposit hinging on the possibility that there may not be enough kittens born, the deposit is automatically deferred to another litter of choice provided there is an available kitten in the litter after the VIP list has chosen their kitten.
  - \* The purpose of this deposit agreement serves as a guarantee for the amount of deposit.
  - \* Buyer understands the signing the Terms of Agreement form is not proof of purchase only proof that a deposit has been received and is not valid unless both the buyer and seller signs the agreement.
  - \* The deposit will be refunded to the buyer if the breeder fails to make available the above said kitten.
  - \* Breeder reserves the right not to sell said kitten for any reason with the understanding that the deposit will be refunded in full.
  - \* If, through an act of nature or other unforeseen reasons, said kitten which was "reserved" becomes unavailable (i.e., medical conditions or death of kitten), Seller agrees to provide Buyer with a kitten of "like-quality and price" from either an existing litter or from an upcoming litter. Such replacement kitten of "like-quality and price" shall be made within one (1) year from the date the original deposit that was accepted by Kitty Cature Cattery.
  - \* Any expense involving transporting the kitten(s) to buyer from Kitty Cature Cattery's location, should the buyer not be able to pick up the kitten(s) in person, will be the buyer's expense. This is not an option unless the seller agrees to transport the kitten(s) to a designated location of the sellers choice. Otherwise the agreement will be deemed null and void if the kitten is not picked up by the twelfth (12) week of said kitten(s) date of birth. If and only if the seller agrees to make other arrangements for transferring ownership, it will be in writing and not a verbal agreement. You must have a face to face meeting with the breeder before finalizing the transfer of kitten(s). This assures compliance with The United States Department of Agriculture Animal and Plant Health Inspection Service.
- PAYMENT for kitten(s) may be made one of following ways: cashier check, Zellepay (mobile banking with no additional fee or Zellepay.com), Square Cash/Venmo (mobile apps), personal check (for deposit only NOT final payment) or cash.

I do not accept Paypal, money orders, MoneyGram, Western Union.
